SOCIAL MEDIA CONTEST RULES AND DISCLAIMER

- 1. ENTRY:** No purchase necessary to enter or win. During the designated time period, follow the instructions on the designated post and like/follow our page. If you already liked/followed our page you don't have to re-like/re-follow the page. Entrant must adhere to any other additional rules outlined in the post.

Each contest is open only to legal residents of the United States, its territories and possessions, who have a valid Social Security number or tax ID number, over the age of 18 (unless affiliated with Panther Pride Credit Union).
